NO DANGEROUS GOODS



- X NO Gas Bottles
- X NO Jerry Cans
- X NO Lithium Batteries

PERSONAL IMPORTS

- GST exemptions apply for some personally owned vehicles
- A GST reduction applied on a sliding scale based on the length of ownership from 3-12 months
- ✓ Vehicles owned more then 12 months are GST free
- There are compliance concessions for vehicles which have been owned by the importer for more then 21 months

COMPLIANCE REQUIREMENTS

- ✓ Euro 6 Emmisions
- ✓ Electronic Stability Control
- Concessions to the above apply to vehicles which have been owned by the importer for more then 21 months
- PPSR No Water Damage or Finance
- PDI (new vehicles only)
- ✓ If unsure then contact the below compliance authorities

BIO-SECURITY / MAF

- Ensure vehicle is fully cleaned before export from Australia
- ✓ A MAF inspection will take place on arrival in NZ
- ✓ Further cleaning charges will apply if the vehicle fails MAF inspection
- ✓ No Personal items inside the vehicle



REMOVE ALL DIRT & PLANT MATERIAL

Vehicles with loose soil / dirt / plant material may not be accepted by the shipping line

CHECK LIST

- ✓ Autohub Booking
- ✓ Purchase invoice or valuation
- ✓ Odometer Reading
- ✓ PPSR
- ✓ Cleaned vehicle
- ✓ All personal items removed
- Understand NZ compliance requirements for your vehicle

MOVING OVERSEAS?

- ✓ Removed Registration Plates
- ✓ Deregistration
- ✓ Cancelled Insurance
- ✓ Have current PPSR
- ✓ Any Finance is finalised
- Checked compliance requirements at destination

CUSTOMS CLEARANCE

- √ 15% Import GST applies on CIF value to non concessionary vehicles
- ✓ Tax exemptions may apply for personal imports
- Odomoter reading mandatory

Ensure paperwork in order to not delay clearance
